Distributing naloxone in El Dorado County is critically important because it saves lives in a community that, like many others, has been deeply affected by the opioid crisis. Naloxone is a safe, easy-to-use medication that can quickly reverse an opioid overdose, giving people a second chance and time for emergency help to arrive. Making naloxone widely available to residents, families, and community organizations reduces preventable overdose deaths and empowers the community to act in moments that matter most. Beyond its immediate lifesaving effects, naloxone distribution also helps reduce stigma around substance use and opens doors to treatment and recovery services.


